All vendors wishing to participate in the event MUST agree to the following conditions:

- 1. Tables will be provided for vendors according to the quantity and table size shown on the second page of this agreement. Please let us know if you are not interested in using our tables. (Rental space is approximately 10' x 10').
- 2. Vendors will be placed on the Church festival site at the discretion of the Festival Committee.
- 3. Vendors are responsible for all items necessary to display their goods. This includes showcases, lights, tablecloths, extension cords, etc.
- 4. Table cloths will not be available for your space.
- 5. The Church will provide credit-card verification. Only one telephone line is available for all vendors. Therefore, it is strongly recommended that vendors bring portable credit-card machines to utilize during the weekend.
- 6. VENDORS ARE RESPONSIBLE FOR TIMELY SET-UP AND BREAK-DOWN OF THEIR SPACE. All vendors are expected to be operational on Friday, February 21, 2025 at 11:00 a.m. and to be cleared out of their area by 7:00 p.m. on Sunday, February 23, 2025.
- 7. Vendors are responsible for all business transactions and are responsible for manning their displays, securing cash, etc.
- 8. Security will be provided on site from Thursday, February 20, 2025 at 10:00 p.m. through Sunday, February 23, 2025 at 7:00 a.m.

- 9. The Church is not an insurer and will not be liable for any theft, loss, or other casualty to any vendor's equipment, merchandise, or currency. The Church will not be liable for any damages whatsoever resulting from your occupancy of the leased space, including personal injury and property damage. Vendors should obtain insurance coverage for their own protection.
- 10. Vendors are responsible for leaving the Church property in the same condition it was prior to their occupancy.
- 11.Vendor agrees to pay a flat fee of \$______ for all days of the festival. (\$500.00 for 1-2 tables, \$600.00 for 2-3 tables, \$700 for 4-5 tables). Half is due with the signed contract, the remainder is due by February 1, 2025. No refunds will be made except in the case of Acts of God. All vendors will be set up outside of the main tent, in our Vendor Market area behind the church. Electrical hookup provided. Bring your own extension cords.
- 12.Please make your check payable to <u>St. Nicholas Greek Orthodox Church</u>. Mail your check and the signed agreement form to the Church at the address listed above, to the attention of the 2025 Festival Chairperson. A receipt will be sent to you as soon as the Festival Committee received the signed agreement form and the check has cleared. Food vouchers will NOT be issued to vendors.
